



# TRACK DOWN YOUR LOST SUPER.

Here's how:



#### Visit myGov

Go to [my.gov.au](http://my.gov.au) and sign in or create a myGov account. Link your myGov account to the ATO (if you haven't already).



#### Find your super

Select 'Super' from the menu in your ATO account. Here you'll see all your super accounts, including any that you may have forgotten about, and any super held by the ATO in your name.



#### Consider your situation

Before consolidating your super, you should check with your existing super fund whether there are any fees or charges that may apply or any loss of benefits, such as insurance cover.



#### Transfer

Consolidate your super into your Hostplus account.
